Mayor Jeffrey Hornburg called the meeting to order.

Pledge of Allegiance to the Flag.

Roll Call by Clerk Postle: Present: Mayor Hornburg, Trustee Kelly, Trustee Burt, Trustee Romanik, Trustee Cummings, and Attorney Clark.

Motion made by Trustee Romanik seconded by Trustee Cummings to approve the minutes of the September 16th, 2019 Regular Meeting as presented. Trustees Kelly, Burt, Romanik, and Cummings voting aye, Carried.

Motion made by Trustee Burt seconded by Trustee Kelly to approve the payment of the bills appearing on Abstract No. 4, including claims numbered 21871 through 21921 in the amount of \$215,748.62, and Abstract No. 2 Capital Project (I&D) claim number 172 in the amount of \$139,047.45 following proper audit with no exceptions. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Floor Opened to the Public for Comments/Concerns of the Village Board:

Jack Freeman - Complaint of neighbors fence being out of code compliance. Wants it to be fixed and wants the board to make her to remedy the fence. Mayor Hornburg stated that the matter is in the courts hands.

Ann Vickers - Claims that Anna Frederickson does not maintain both sides of the fence between their yards. Trustee Kelly suggested that Ms. Vickers should put in a complaint with code enforcement.

Bill Kuppel - The DPW did a good job on the Front Street paving.

Louis Pelletter - Asked if the Village is going to install a handicap ramp or elevator at the dining car. Trustee Burt will follow up with contractor for elevator and door. The inside of the car is primed, and the Silver Creek School Band members have volunteered to paint the car. Clerk Postle will check with the insurance to make sure we are covered. Also looking for the historic benches that were stored at the DPW. Working on the roll of honor and hope to have it done for Veteran's Day.

Sandra Lindstrom - Asked if there will be time to blacktop the track in the ball park.

New Business:

Motion made by Trustee Kelly seconded by Trustee Burt to approve payment to 3 Pete's Masonry for the dying and sealing of the concrete perimeter of the Village Fountain in the amount of \$1,120. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Kelly seconded by Trustee Romanik to approve payment to Southpaw Signs for 2 plaques for the Village Fountain naming committee and donors in the amount of \$1,368.80. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Burt seconded by Trustee Cummings to accept the Silver Creek Court Report for the month of September, 2019. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Cummings seconded by Trustee Burt to approve the Mayor's appointment of Jim Tytka Sr. as an alternate member of the planning board. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Burt seconded by Trustee Cummings to remove \$7,014.88 from water/sewer account 20-0930, 46 Babcock. The property was abandoned and purchased by the Chautauqua Count Land Bank and demolished. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Cummings seconded by Trustee Burt to accept the Village Tax Collectors report of unpaid taxes in the amount of \$124,216.00. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Motion made by Trustee Romanik seconded by Trustee Cummings to introduce Local Law #3 of 2019 amending Chapter 60 of the Village Code, and set a public hearing for October 21st at 6:30pm. Trustees Kelly, Burt, Romanik, and Cummings voting aye. Carried.

Mayors Comments: Discussed quote on awning replacement for clerks office entrance. Trustee Kelly suggested contacting Jamestown Awning. Clerk Postle will call for a quote. The annual audit is done and Laura from BLB will come in to go over it with us. Eileen Powers from CHRIC will be at our November 4th meeting for a public hearing to discuss a Community Development Block Grant the we will be applying for . The hearing will be at 6:45 PM with the regular meeting to follow. We will a mandated Sexual Harassment training for the employees tomorrow at 2:15 pm. Village Attorney Peter Clark: Nothing at this time.


DPW Mayor reported: Should be paving Steward this week with weather permitting.
